# Getting Started



Waterfront Learning works in partnership with your home school district or non-public school to offer online courses on a full-time or part-time basis. Students and parents shall work with a designated member of your local school's staff (known as the liaison) to enroll in the program.

Once you and your district design an online learning plan for the student, the following will occur:


- The student will be registered for a course or courses using our student information system (Genius Student Information System).
- The Waterfront Learning Team will utilize one to two business days to review and process the learner's enrollment.
- The student, parent, and school district will receive a "Course Registration" email notification that provides instructions to begin the coursework.
  - *Please note that at the time of enrollment, additional courses may appear on your dashboard. These courses may list a course entitled Support Course. **The student does not need to work in these courses. They are "placeholders" intended for office use. There is no work associated with these courses.***
- A teacher/facilitator will communicate with the student and parents/guardians to outline expectations. The teacher will maintain contact and provide instructional support throughout the duration of the student's enrollment.
- Upon completion of a course, a "Grade Report" containing a final grade percentage will be emailed to parents/guardians, students, and the local school district.
- Parents/Guardians can monitor student attendance, performance and progress at any time during the online experience by creating a "Guardian Account" in our student information system. **Complete instructions on how to complete this process are included at the very end of this handbook.** This access, coupled with our desire to maintain student confidentiality, eliminates the need for the communication of confidential student information via weekly emails from the teacher.

**It is the expectation of the program that all parents/guardians create and consistently access their guardian accounts to help support their online learner!**

# Orientation Program



Each platform has a unique orientation program. Any of the following may be included in the orientation for a student, depending on the assigned vendor:



Through the vendor-provided orientation materials, students can expect to learn how to:

- Navigate the learning management system (LMS) or platform
- Access courses and assignments
- Determine pacing
- Review grade information and feedback
- Utilize support features built within the system, such as digital textbooks or live support options

Please remember, if you ever have any questions about how to navigate any of the systems, you can review these materials again, or reach out to your teacher or the Waterfront Learning team for support.

# How to Access Your Courses



1. Go to <https://www.waterfrontlearning.com/login> and type in the student username and password. Click on **Login**.

*Note: Please be sure to use your student login provided in the "Course Registration" emails, not the Guardian's login information.*


**Exceptions:** Please note that if you are to log in using another website (i.e Driver's Theory or eDynamic), an additional email will be generated at the time of enrollment and will provide you with the website, instructions, and credentials to log in. For those courses, the grades will not automatically update in Genius, the teacher will manually input the grading and progress information into the system weekly.

# Five Pillars of Success



Working together, we are confident that all students can be successful! Your success is dependent on five key areas:

- Orientation
- Attendance
- Pacing
- Performance
- Communication



# Pillars of Success



<b>Pillar</b>	<b>Expectations</b>	<b>Student Actions</b>
<b>Orientation</b>	Each student should complete the Orientation program provided within seven days of their start date.	<p>Complete the Orientation video within seven days.</p> <p>Families will be provided with additional support materials when available.</p>
<b>Attendance</b>	Each student should log into their courses for at least one hour per course at least five days a week. Students should follow any assignment calendars and due dates provided in the platform	<p>Work in each course daily and use the tools in your course to monitor your pacing (assignment calendar, daily planner, or teacher provided guides) to ensure that your course is completed on time.</p> <p>Notify your district liaison in advance if attendance for a particular week will be different than expected with an explanation for not working.</p>
<b>Pacing</b>	All students are expected to be "At Pace" or "Ahead" in all courses. Students should complete work as indicated in their assignment calendar, daily planner, or teacher provided pacing guide.	<p>Complete all assignments listed for their daily tasks (if provided) or as many activities as directed by the course teacher for a specific platform.</p> <p>Communicate concerns or questions regarding progress/pacing to your teacher.</p> <p>Notify your district liaison and teacher in advance if there will be a reason for not completing assignments as expected.</p>
<b>Performance</b>	All program performance default settings are 70%. Modifications to the performance standard can be made on a case-by-case basis when approved by the district cyber liaison.	<p>Complete course work and assessments to the best of your ability.</p> <p>Contact the teacher and ask for help when having difficulty with understanding content or completing an assignment.</p>
<b>Communication</b>	The student will engage in communication with the teacher of the course at least once a week. (Phone, email, chat, virtual classroom, etc.)	<p>Notify the teacher when and how you wish for them to communicate with you. We recommend setting up a weekly schedule (ex: Phone calls on Wednesday at 6PM).</p> <p>Notify your district liaison in advance if you will be unable to be contacted for a period of time.</p> <p>Respond to all teacher communications within 24 hours.</p>

# Tiered Intervention



Waterfront Learning utilizes the following Tiered Intervention process for providing student support to all students. Please refer to the information below to better understand the communications you may receive should you not meet one or more of the expectations listed on the previous page for the "Pillars of Success."

<b>Tier Level</b>	<b>Explanation of Tier Level</b>	<b>Actions</b>
<b>Tier I</b>	All students begin on Tier I. Students that continue to meet the minimum expectations for the Pillars of Success will remain here.	Students will continue normal weekly communication with all assigned teachers.
<b>Tier II</b>	Students not meeting the minimum expectations for the Pillars of Success are moved to Tier II.	<p>An email notifying the student, family, and district will be sent indicating that the student has been added to the Tier II Watch List.</p> <p>The student will need to work with their assigned teacher to put together a plan to get back on track with all courses.</p> <p>Once back on track, the student, family, and district will receive an email indicating that the student has been removed from the Watch List.</p>
<b>Tier III</b>	Students that showed little or no improvement after being placed on Tier II, and/or are at risk to not earn credit for the course(s) are moved to Tier III.	<p>An email notifying the student, family and district will be sent indicating that the student has been added to the Tier III Watch List. This email will also request a meeting including the student, family, district and Waterfront Learning representatives.</p> <p>Waterfront Learning will contact the district liaison to discuss potential interventions and supports for the student.</p>

# A Note About Integrity



At Waterfront Learning, we expect that students will do their own work, following all district policies, guidelines, and procedures. Cheating, plagiarizing, and acting in an inappropriate manner will not be tolerated. In the event that a student's actions violate program or district policies, **Waterfront Learning has the sole discretion to modify or remove the student's online course access.** To participate in Waterfront's program, students must have a signed **Acceptable Use Policy** form on file for the current school year with the district.

Our teachers will check student work to be sure the work is unique. If the work is found not to be the student's own, disciplinary action will be taken as per district and program policies.



<b>FIRST OFFENSE:</b>	The student, parents, and district will be notified. Pending the outcome of this communication, the student may be asked to redo the assignment.
<b>SECOND OFFENSE:</b>	The student, parents, and district will be notified. Pending the outcome of this communication, the student may receive a zero on the assignment.
<b>THIRD OFFENSE:</b>	The student, parents, and district will be notified. Pending the outcome of this communication, the student may lose partial or complete course access.

Examples of Integrity Mishaps:

1) Plagiarism

- Copying and pasting passages from Internet sources
- Copying work without properly giving credit to the source or person
- Taking credit for someone else's material

2) Cheating

- Providing questions/answers to other students
- Receiving questions/answers from another student
- Having someone else complete your assignments on your behalf

Some Prohibited Behaviors:

1. Giving or receiving answers
2. Attempting to have any person other than yourself complete your work
3. Copying or pasting information outside of your class
4. Displaying threatening or bullying behavior
5. Not following the rules set forth by Waterfront Learning and its partners, including entering into an unsupervised office hour and tutorial sessions.

***Waterfront Learning has the right to suspend access to platform features or entire courses if an Acceptable Use Policy violation occurs.***

**Please note:** Students may not post any questions or answers to any website or social media, nor may the student share course files with anyone other than the teacher of their course.

# Grades, Credits, & Attendance



Waterfront Learning is your local school's partner in online learning. We work closely with a large number of school districts across the Commonwealth of Pennsylvania. Keep in mind that we create customized online programs that meet the needs and requirements of local schools.

Please note that your child remains on the role of your local school while enrolled in Waterfront courses. Therefore, the following items are determined by the learner's local school district:

- **Grading Scale and Report Cards:** In conjunction with our online learning platforms, Waterfront Learning will provide percentage grades to the local school district. The district determines if the grade is considered to be passing or failing based on their board approved grading scale. The school district will provide a report card to parents and student based on their uniquely scheduled quarters, semesters, and final grading periods.
- **Credits and Graduation Requirements:** Each local school district has unique requirements to earn credits and for graduation. The student's local school district issues credits and can provide an official transcript for the learner when requested properly. In addition, they will determine if a child has met graduation requirements.
- **Attendance:** It is expected that students attend school regularly. Waterfront provides attendance data to school districts who will determine if a child is meeting attendance requirements. The district maintains the responsibility to adhere to their attendance and truancy policies and procedures.
- **Extracurricular Activities:** If a student is interested in participating in extracurricular activities, they should contact their local school district to determine eligibility and scheduling.


**It is expected that parents and students contact the local school district liaison to obtain report cards, letter grades, credits, transcripts, extracurricular activities, and truancy issues.**

# How to Create a Guardian Account



A “Guardian Account” in Genius is an account that a parent or guardian can utilize to progress monitor a child while working online through Waterfront Learning. This account will allow the parent to access the student’s attendance, performance, and progress at any time. **Genius updates nightly with the course platforms; any work done on a specific day will be reflected in the Genius information the following day.** Using this account regularly to progress monitor will help the parent to work in collaboration with the education team towards the common goal of student success.

1. Once logged in as a student (through <https://www.waterfrontlearning.com/login>), click on **Add Guardian** on the menu on the left side of the screen.



2. Complete the required fields for the guardian and click **Save**.



3. To access the guardian account, use the same website as the student account (see step #1).


4. Click on **Academic Snapshot** on the left side menu to see the progress and grades for each course.



# Support & Technical Assistance



For course or technical assistance, students should reach out to their assigned teacher ***first***, and then to the Vendor Technical Support or Waterfront Learning Central office team if necessary. The need for assistance would include, but is not limited to, assistance with content questions, grading, pacing, accessing quizzes/tests, viewing videos, needing additional attempts or retakes, etc. ***Please be sure to always include your name, grade, contact information, and concern in your communications.***
