 SUBJECT: **INTERNET REIMBURSEMENT**

The Allegheny Intermediate Unit will reimburse the families of 2020-2021 Waterfront Learning students **utilizing program hardware** for home Internet access service charges, **one per household**, commencing with the student's effective enrollment date. The maximum reimbursement per family is **up to \$35.00** per month and is payable quarterly. If your Internet is a part of a package by your provider, you will be reimbursed for the portion of the bill that is for the **Internet service only** not to exceed the \$35 limit.

The reimbursement schedule for the 2020-2021 school year is below. The Internet Reimbursement Form must be received by the due date to receive the quarterly reimbursement. Unfortunately, late submissions to Waterfront Learning will **NOT** be processed. *Please allow at least 30 days from the deadline for process and reimbursement of payment.*
